General

- All quotes are made and orders accepted upon and subject to the following conditions of sale which shall operate to the exclusion of any other.

Prices

- All prices listed or quoted are subject to change without notice.
- All orders are accepted on the condition that the prices charged will be those current at the time of despatch.
- All prices shown on this website are inclusive of VAT charged at the current rate of 20%.
- All prices quoted will not include VAT.

Quotations & Orders

- Quotations issued will remain valid for a period of 30 days only from the date of issue unless otherwise stated & represent no obligation on the part of SED until an official Purchase Order has been accepted.
- An official Purchase Order must be identified with an order number & must contain all relevant information.

Delivery

- We deliver (To account customers only) via our own transport to area's in the West Midlands (Please ask for further details).
- Orders over £60 (Incl VAT) are carriage paid for deliveries on our van.
- Orders below £60 (Incl VAT) may be sent on carrier & carriage will be charged at cost (Please see Carriage Charges below).
- Delivery days will be confirmed at the time of order.
- Whilst every effort will be made to maintain agreed delivery dates we will not accept liability for losses of any kind arising due to any delay or failure of a delivery.

Carriage Charges

- All parcels are sent on an overnight service unless otherwise requested.
 - 3PM Cut off time for parcels to be sent on carrier.
 - Overnight rates as follows,
England & Wales - £10.80 Up to 20 Kilos & 31p per Kilo thereafter up to 100 Kilos.
Maximum weight for each parcel must be no more than 30 Kilos. 100+ Kilos 35p thereafter.
 - Timed rates as follows,
England & Wales - AM Extra £9.60 per consignment
10AM Extra £16.80 per consignment
9AM Extra £22.80 per consignment
Sat AM Extra £27.60 per consignment

Terms & Conditions

Collections

- No minimum order value for collections.

Cancellation & Returns

- Cancellation will not be accepted for non-stock items. Cancellation for stocked items may be accepted but only with our agreement first.
- No returns will be accepted for any reason unless our consent has been obtained in writing.
- If an item has been ordered incorrectly & we agree to have it back a 15% handling charge will be charged & all return costs will be paid by the customer.
- All returns must be in their original packaging.

Damages & Loss in Transit

- We will not accept liability for damages to or loss of goods sent on carrier (Please see full details of our carriage charges).
- In the case of any damages or shortages with a delivery made by SED or a collection from SED we must be notified within 3 working days of receipt of order otherwise all goods will be deemed as invoiced & no claims will be accepted.

Terms of Payment

- 30 Day accounts must be settled by the last day of the following month from when the goods were supplied.
- We reserve the right to suspend an account when it is overdue.
- We accept all major debit & credit cards.

Title

- All goods will remain the property of SED until all payments due under the agreed contract made between SED & the buyer have been made in full.
- If the goods are not paid for in full we reserve the right to remove these goods from the buyers premises & re-sell the goods.

Risk & Insurance

- All goods shall be at the risk of the customer from the time of delivery / collection.

Law

- Any question of law relating to these conditions or agreed amendments or the terms of any contract between the buyer & the seller shall be determined in all respects by the Laws of England.
